## 8. <u>CALIFORNIA SPECIAL DISTRICTS ASSOCIATION (CSDA) CALL FOR NOMINATIONS FOR BOARD OF DIRECTOR SEAT A</u>

Purpose is for the Board of Directors to review and discuss the CSDA call for nominations for a seat on the CSDA Board and determine Fire District participation.

Clerk of the Board Heney stated that CSDA is currently accepting nominations for a CSDA Director seat for the Southern Network. This seat is a three-year term expiring in 2024. The Fire District is eligible to nominate a District Board Member or managerial employee, for election as a CSDA Director.

Clerk of the Board Heney stated the CSDA Board of Directors is the governing body responsible for all policy decisions effecting CSDA's member services and legislative advocacy, education and resources. The Board represents the common interest of all California's special districts before the Legislature and the State Administration.

Clerk of the Board Heney stated that CSDA's Board of Directors is made up of six geographical networks. Each of the six networks has three seats on the Board with staggered 3-year terms. Directors are nominated and elected by network. Chino Valley Fire District is included in the Southern Network which represents the counties of San Bernardino, Los Angeles, Orange, Riverside, San Diego and Imperial.

Clerk of the Board Heney stated that the incumbent for Seat A is Jo MacKenzie from Vista Irrigation District. The incumbent has expressed a desire to run for re-election.

Clerk of the Board Heney stated that if the Fire District Board of Directors elects to submit a nomination, a copy of the Fire District's minute action and Candidate Information Sheet must be submitted to CSDA by March 29, 2021.

Clerk of the Board Heney stated that all qualified nominees received by CSDA will be placed on the election ballot. This year CSDA will be using a web-based online voting system, allowing the District to cast its' vote easily and securely. Electronic Ballots will be emailed to the District by May 28, 2021. All votes must be received through the system no later than 5:00 p.m. July 16, 2021.
