SUBJECT: Master Fee Schedule Revision

This memorandum is intended to provide clarification on two fee codes within the Master Fee Schedule. Both fees are a fee for service and as a Fire District we are allowed to charge the customer for the said service. The fee is to be in line with the staff time allocations of the service provided. It was determined that with both fee codes, a higher time allocation was applied in error, the corrected amounts are reflected below:

Fee code 1210 (Tract Phase Plan Review per Lot) was approved at the amount of \$794.00. The fee code will be reduced to **\$335.00**.

Fee code 1750 (High Piled Storage each additional 100,000 sq.ft.) was approved at the amount of \$889.00. The fee code will be reduced to **\$444.00**.
