PLAN REVIEW SUBMITTAL PROCESS

Prior to plan submission to our office, plans shall be reviewed by one of our approved Plan Check Consultants, except for 4 specific plan types. (Please reference in-house plan review information)

Chino Valley Fire accepts electronic plans; however, you may be required to submit a hard copy set of plans to the consultant. This initial review process will require fee(s) to be paid directly to the Consultant for services rendered.

Once the plans are reviewed and stamped recommended for approval by the consultant, plans and all pertinent documents shall be submitted to our office in a PDF format. The plans shall be named in the following manner: Project Address_Project Name, if applicable. (Example: 14011 City Center Drive_Chino Valley Fire)

CONTRACTORS:

Plans shall be submitted via the online permit portal, located on our website at www.chinovalleyfire.org.

Please note: If you do not have an account set-up, you will need to set-up an account first. Information is located on the home page of the permit portal, as well as on the Permits and Plan Review webpage.

ARCHITECTS/ENGINEERS/ PERMIT RUNNERS:

Plan submittals are accepted in person or via e-mail (permits@chofire.org). An application is required, along with an electronic (pdf) set of plans.

Office hours: Monday - Friday, 8:00 a.m. to 5:00 p.m. Questions can be directed to (909) 902-5280 Option #2 or by e-mail permits@chofire.org.

The plans will have a final review by our office. Our plan review process time is 7 to 10 business days. There will be an associated fee collected at the time of submittal. This fee covers our final plan check review, permit and required inspection(s). Fees are due at time of submittal or as outlined in the terms and conditions. All fees are non-refundable.

When required by a projects conditions of approval, a separate detailed site plan shall also be submitted, in accordance with CVFD Standard 143. Please note: All new tracts and/or developments require this submittal. Failure to submit this at the time of plan check will cause a delay in the review process.

IN-HOUSE PLAN REVIEW:

- Single Family Dwelling Construction, including tracts and additions, regardless of the percentage to the original structure. Submittal shall include a current fire flow. Please note: Fees for additions are paid at time of pick-up due to fee review determination.
- Photovoltaic &/or Back-up Battery System for PV.
- Fire Sprinklers - 19 heads or less
- Fire Alarm - Communications alteration
